Dear friends, dear co-patients,

Enclosed you find copies of our statement on the ELECTROSHOCK - as one method of torturing patients - sent to Mr. Clark.

Except of your participation in the Ontario Coalition To Stop Electroshock we know nothing about your experiences, difficulties and aims. We would like to offer you our help, but this will be only possible if we know more about you. Without a better understanding and knowledge of your situation we cannot decide if and which one of our achievements will be helpfull for you. Since our articles and books are in German and since it will take us a lot of work and time to translate also only parts of them, we cannot start this work without knowing positively that you really need them.

It would be a misunderstanding if you take this for inmodesty. Our writings are the result of a more than 14 years lasting period in which we had continuously to create and develop new forms of resistance. Sometimes about 500 patients were involved. The efficacy of these new forms of resistance is proven (eg. in the isolation torture of prisons).

Enclosed we are sending you documents of the resistance of patients against the medical man and his methods of torturing patients, the so-called treatment of illness. One of these methods of torturing is the ELECTROSHOCK.

The ELECTROSHOCK - like all other treatments - pretends to cure the patients' illness, pretends to "cure" only the illness. In reality it annihilates all potentiality of awareness of this illness, leaving back a destroyed human being, but a so-called normal one, a paragon of the medical man's picture of men. The medical man's wish seems fulfilled: he has created a docile and obedient creature, who believes that all torture has be done to his best and who is full of trust in the medical man.

In most cases - if this patient isn't a real lucky dog and if his illness isn't stronger than the medical man he is condemned to vegetate - the potential of vitality remaining him is only sufficient to eat, drink and sleep.

World-wide each society is ruled, regulated and mastered not only by the value of money. The bigger value is the so-called health.

We are writing out of a country in which - not long ago - the medical men made one of their greatest experiments in history, called "das III. Reich" or Nazi-Deutschland. We have learned - and no medical violence will be able to force us to forget that

- this experiment started in the 18th century in Great-Britain with the Society for Eugenik, an organisation of medical
- each idea of health and illness in each society is produced and ruled by the medical men. It are always the patients with whom they start their murderous business
- in the name of health, synonymous for each racism, hundred thousands of patients inside and outside of HEILanstalten were tortured and killed, defined by the medical men assunworthy life (unwertes Leben)
- following this mass-murder, the medical men "treated"

 the illness to-be-a-Jew and tortured and killed each
 bearer of this illness, 6 millions Jews in the KZ's
- the bearers of the illnes to-be-a-communist were tortured and killed
- the medical men as members of the party of Nazis did not need to do all the torture and murder personally. They implanted their murderous ideas in everyones body and head and camouflaged it as objective scientific research
- after the end of the III. Reich, the same medical men took over the universities and HEILanstalten

- their business is still the same: they select the unnormal ones, treat them with torture until the patients are normal or dead. The medical man has "developed" his treatment of illness: instead of euthanasy it's now differential euthanasy, the patient is some-times allowed to die in a longer period of time - he is condemned and buried lifelong.

It is not relevant whether the medical man is a kind one or not, objective he is the exponent of a murderous business and he is gaining good money out of the illness of the patients.

The patient - like the servants in every master-servant relation - does not need the medical man. He does not lose his illness if the medical men don't exist. The medical men without patients and their trust in the "medical art" - are nothing. The medical men are defined as the rulers of illness - if the patients discover their illness as the only means for awareness and the creation of a real new world (utopathy) in which the human beings is all and any value is nothing - the medical men are superfluous.

As long as patients take over the medical man's picture of the purebred race the stone agesold history will happen: They are condemned to act like it happened also in Auschwitz. Tortured creatures who were lucky to go to the gas-oven because they believed what they were told: their illness being the cause for all trouble and disaster in the world.

There is no middle-way between the concept of illness as the only substance capable of bearing future for the human being - or the medical art with no future than the past, the stone ages old concept of "treating" illness and annihilating the bearers of illness.

Contributors to this memorandum are:

patients in- and outside of the HEILanstalt Wiesloch (Psychiatric State Hospital of Wiesloch), lawyers of illness and assistant lawyers of illness as afflicted ones.

Purpose:

Through publication, condemnation and struggle against the criminal practices of physicians one has to prevent the physicians in the HEILanstalt (asylum) Wiesloch to continue their therapeutical terror against patients in the form of nerve poisons, scalpell and shock, brainwashing and torture-treatment and of causing further deaths.

Likewise care should be taken to prevent the physician-induced epidemic of declaring lawyers and assistant lawyers insane to spread further through Western Europe.

Aim:

The physicians in responsability have to be put under effective surveillance and control.

The deputees of the above mentioned organisations have adopted the task of

- hearing the accusations of the patients against the physicians
- intervening against the criminal acts of the physicians amongst the authorities.

Human Rights are an achievement of the Age of Enlightenment, which started when the New World was preparing to strive for independence (1776) and when faith-healers and racists in the clerical and aristocratic establishment were being overthrown (1789ff).

Names which are associated with these movements are Jean-Jacques Rousseau, Voltaire and Montesquieu, but also Machiavelli, Fredericus Rex of Prussia et al.

This document is aimed at and able to enlighten similar social conditions today. The focus and source of these social conditions is not localized exclusively in Wiesloch today, nor was it, from the American point of view at that time, to be found in London or in Versailles from the Parisian point of view.

It is self evident that tolerance ends where human beings and human rights are violated because otherwise tolerance is criminal collaboration instead of being the very heart of the Age of Enlightenment and the final aim not only of liberal politics. The Belgian Association for Human Rights has to investigate and condemn violations of human rights irrespective of the question who has committed them.

The people which were victims of these violations are listed in every page of this document. The document also gives a detailed specification about which of their rights has been violated. To realize that one doesn't even have to read between the lines. The violations of Human Rights are specified in the following.

Those who want to prevent repetitions of murder and second degree murder in the HEILanstalt should not miss any occasion to write down and list page for page, hour for hour, year for year these avoidable repetitions.

If one decides to work along these lines of resistance this is the only way to make sure that avoidable repetitions do not take place:

Medical treatment by force (Zwangsbehandlung) especially the forcible administration of nerve poisons e.g. psychopharmaca and neuroleptics is against the Fundamental Law (Grundgesetz) of the Federal Republic of Germany and against Human Rights.

- (1) (dignity of men)
- (2) (fundamental right to live and remain physically unharmed)
- (3) (fundamental right that all men are equal in front of the law)
- (5) (freedom of speech)

of the Fundamental Law and the following Human Rights:

Article 3 (Human Right of Life and Freedom)

Article 5 (Interdiction of torture, inhuman treatment and violations of the human dignity)

Article 18 (Freedom of speech, opinion and religion)
(General Declaration of Human Rights of the UNO 1948).

Paragraph 2 (2) of the Fundamental Law of the F.R.G. guaranties that

"everybody has the right to live and remain physically unharmed. The freedom of the individual cannot be violated. These rights can be restricted by means of a law alone."

Still in February '76 when the front of patients made a thrust against the RESEAU INTERNATIONAL of Psychiatry, the patient G.H. was amazed and half-incredulous about the acts and theses of the front of patients:

The discovery of medical practise as the race-creating violence (Iatrarchy) on world scale. At the same time the strategical mark, target and object of man's liberation.

A year later, being a prisoner in the clinc and in the specified situation of a patient in resistance he become aware that the medical man is the ruler and master (archiater) of torture and euthanasy. His revolutionary identity (epilepsy) was honoured with 4 years of prison.

It isn't and it never has been the state but it are the medical men - the fundament of hope for every despote for the "save" of the human being from the world-wide "pestilence" of resistance and revolution.

From the organisatorial side it is the whole complex World Federation for Mental Health (WFMH), (head quarter at the time being in New York) with all it's cross connexions to the World Health Organisation (WHO), the World Organisation of physicians, Social Psychiatry and at the time being "left" socialpolitical groups, rootworks (Rhizom à la DELEUZE & GUATTARI) going through all professions of this apparatus of violence.

It steered the Nazi-fachism from the murderheadquarter (Mordzentrale) T4.

> "Not PIGS, servants of capitalists etc. but in toxical units, meterkilopond and calories measurable and therefore a capitalisticly enhanced violence of nature which we have to overcome"

Volt:

Micro waves are used to force the brain to work only in the medical censored way: mental disorders, breakdowns and interruptions of the nervous system, disturbances of behaviour and metabolism, the blood- and oxygen supply is blockaded in consequence.

With micro waves, sounds and words are called forth in the head of the tortured patient.

The population not only of countries but also of continents can be made imbecile and dull and be eliminated by micro waves.

Toxical units:

poisons (pharmaca) are dropped in the brain with a small electrode or through a tubule.

Effects known as results of the isolation torture can be induced with pills.

For that purpose the medical research registers the "physiological and biochemical correlates" of isolation torture.

Meterkilopond: Purebred supermen as robots / robots as purebred supermen, electrodes in the brain or transistors in their glasses and wrist watch, and a ton-heavy bodyscheme made of

Calories:

In future the iatrocratic wisdom will no longer be eaten with spoons but will be implanted and planted for the sake of security in retardform (mnemotechnics).

This is the newest/latest variation of naturecure. Without any doubt: If the physician isn't a murder then he is: a medical man (medicus curat, natura sanat: the medical man treats only, nature cures; Paracelsus von Hohenheim at the end of the Middle Ages).

Each resistance against the medical men aims toward a society in which nobody needs to become a medical man - because the place taken by him doesn't any longer exist.

A famous example, later honoured with the Dynamit (Nobel) Prize reads as follows:

EGAS MONIZ, one of the series of brain- and gene butchers and sliters, one of the series of producers of retort hermaphrodites always in detail but in each case only following the medical man's picture of man.

This Egas Moniz had tortured since 1936 an unknown great number of patients with the so-called lobotomy (the connection frontal brain-Thalamus is separated by cutting in the inner upper corner of the eye with a kind of a letter-opener). In the 1940's a patient tortured by him in this brain surgical way proved that illness is able to resist each medical attack. The patient fired 5 times.

It is told that Dr. Moniz, sitting paralyzed in a wheel chair, meditated for years about the indestructible resistance of patients and about the transitoriness of the medical art.

Declaration

Herewith I declare my refusal to be treated any longer with neuroleptics and other psychopharmaca as applied by the physicians and medical guards of the Psychiatric State Hospital of Wiesloch.

I call attention to the fact that a treatment with psychopharmaca violently undertaken without my consent and against my will, whether with injections i.m. or with medicine secretly mixed in the food, fullfill the penal facts of dangerous bodily injury respectively the penal facts of heavy bodily injury (§§ 223, 223a, 224 german penal code - Strafgesetzbuch (StGB)) which can be punished with imprisonment up to five years. But equally any attempt to force me by threat (to get locked up in the cells of K3) to take the medicines mentioned above, can be gravely punished as duress in the sense of § 240 of german penal code (StGB).

What everybody knows, I had to experience at my own body as object of a medical experiment: the medicine which is applied to me and which at most stabilises the illness or covers the symptoms (see magazine "DER SPIEGEL" No 42, 1976), is not able to cure my illness, because it does not reach the cause of my suffering.

In contrary: The main point of attack especially of the neuroleptics is - as well known - the axis between the diencephalon and the hypophysis (Bahn Zwischenhirn-Hirnanhangs-drüse) which irreversibly gets destroyed by long-time treatment. By this I get deprived of any possibility to unite my feelings, wishing, hoping and my will with my thinking brain, not to speak about the secondary effects (i.e. extrapyramidal symptoms).

I know, that the chemical strait-jacket three times a day aims to transform me slowly but sincerely into a will-less robot, who is just good enough to turn screws or to plane planks.

By the daily impoisoning I am submitted in the Psychiatric State Hospital of Wiesloch, the chance of a release on conditions dwindles year by year. The slowing down of the formation of thoughts, corpulence, impotence, eyes like a dead fish: that is not my illness but the result of the murderous treatment. By not knowing the mentioned interrelations the judges who formally have to decide about my staying here every year, may be confirmed in their saying that they can not justify a release on conditions, but in any case the judges are pinned down to the false stereotypical statement of the physicians who say that "in the personality structure of the patient nothing has changed since the last examination".

My refusal to take the life-destroying chemicals any longer is the first step on my way to the release from the Psychiatric State Hospital of Wiesloch, because by that at least a spreading of the disease Wiesloch is prevented for my person.

Dear Friends,

Especially since we absolutely agree with the exclusion of all persons collaborting in any form with the medical violence, we regret very much that we cannot participate personally at your conference/demonstration.
